## Parent PLUS Loan requirements are as follows:

- ☑ You must be the parent/step-parent of the student whose information is reported on the FAFSA. (Guardians & grandparents cannot apply.)
- File the Free Application for Federal Student Aid (FAFSA) with the Department of Education
- ☑ Complete all sections of this pre-application and return it to the Office of Student Financial Aid (address/fax number below).
- ☑ Sign the electronic Parent PLUS Master Promissory Note (eMPN) at the Department of Education's website at www.studentaid.gov You must have your FSA ID and to sign the Parent PLUS eMPN. This is the same Username and Password that you use to sign your student's FAFSA. The signature process is complete once you can view the screen that indicates SUCCESS! *Now Print your MPN*.
- ☑ Complete the PLUS request process at www.studentaid.gov. This is separate from the MPN and must be completed in order to get the credit approval or denial. Credit check expires in 90 days.
