I. NARRATIVE GENERAL DESCRIPTION

The Allied Health Instructor at Coffeyville Community College is responsible to the Dean of Career and Technical Education and the Columbus Technical Campus Coordinator for instructional and personnel matters and to fulfill the requirements as outlined in the Memorandum of Agreement.
